Dear Mr President/Senator/Congresswoman/Congressman,

Previous communication with your office informed you of corruption hindering our efforts to ship critically needed humanitarian aid into Ukraine. Prime Minister Reva's TASK GROUP has developed corruption to the greatest level since 1994!

This situation has devolved to the most serious level of corruption that we have seen in shipping humanitarian aid into Ukraine. Now Reva's TASK GROUP has weaponized Ukraine's National Police and sent it on a "witch hunt" to further intimidate and silence us in exposing the corruption in Kyiv.

I need your help. am writing to ask you to help our organization with a critical problem in Ukraine. For 25 years we have shipped humanitarian aid to Ukraine's medical, social, educational and military infrastructures on a citizen-to-citizen platform. Now we are facing onerous threats!

Corruption in the highest levels of Ukraine's government has caused us to halt efforts. We have pleaded with President Peter Poroshenko, Prime Minister Grosman and Minister of Social Policy Andrey Reva but all efforts are ignored.

Because we have questioned the corruption and exposed criminal actions in Ukraine, we are now targeted by Ukraine's National Police for "investigation of possible criminal actions." This is a bogus charge intended to intimidate and silence us. I am attaching a letter announcing this "investigation." You will notice no charges are specified; no name is mentioned.

The TASK GROUP's actions are designed to extort through fines and fees.

I am asking your office to contact Ukraine by telephone and letter inquiring why this Task Group has become such an obstacle and has insulted American generosity and good will. Please ask your office to contact Kyiv's government and ask why it has directed the National Police to pursue a policy of intimidation and suppression.

I have been told that a direct inquiry from your office will be a significant help in arresting this intimidation. Your contact will show you are aware of this evil.

Please send a letter to the Embassy of Ukraine in Washington, DC and have someone make a telephone call to the Embassy asking why American generosity and goodwill are being insulted by Reva's Task Group and now threatened with an intimidating inspection. Just this simple action will do amazing things for the situation.
